Preface

The vision of the University is to develop as a Centre of Excellence in Legal Education and emerge as a place of professional learning and nurture the idea of service to the people. To translate this vision, the University orients the students to cater to the needs of the society by developing their professional skills and to serve the legal as well as the judicial community and to render legal services. The University nurtures young minds to critical legal scholarship in the academic curriculum, pedagogy and teaching methods at National Law University, Odisha with coordinated efforts to ensure holistic development of the student community.

University Grants Commission in March 2018 granted us the graded autonomy under Category-II recognizing us as a University imparting quality legal educational in India. We are the third National Law School among four National Law Schools that were granted the autonomy status. We have also been ranked recently as the **third best National law school in India** in this year's (2018) India Today's Ranking of best law schools in India.

The First NAAC accreditation assessment of National Law University Odisha was held in September 2016 and the NAAC Peer Review Committee accredited the University with 'A' 'grade. The first AQAR Report was submitted in September, 2017 and the Second AQAR Report, 2018 is placed before the IQAC on September 12, 2018 for perusal, discussion, suggestions and further improvisation.







Ph.D. Programme:

National Law University Odisha, Cuttack encourages quality research and scholarship in contemporary areas. To achieve such objective of quality research it offers both fulltime as well as part time Ph.D. programmes. The Ph.D. (Part-time programme) is helpful for the in-house faculty of the University and other working professionals, whereas the full time Ph.D. programme is for regular scholars. The University is also offering scholarship of Rs. 15,000/- per month for full time Ph.D. scholars to encourage them to opt for full time research in law.

Post Graduate Programmes:

University is offering LL.M. (one year) programme with two specialisations in the following areas: i. Constitutional Law and Administrative Law

ii. Corporate Law and Commercial Law.

5 Year Integrated Interdisciplinary Undergraduate Programme in Law:

The University offers two interdisciplinary undergraduate programmes, namely B.A., LL.B. (Hons.) and B.B.A. LL.B. (Hons.)

1. **B.A. LL.B. (Hons.) Programme**: The B.A. LL.B. programme combines the study of law with social sciences. Sociology, Political Science, Economics, Legal History, English language and Literature are taught as part of the social sciences and Humanities discipline. The university also offers students the opportunity to learn selected management subjects like Basic Principles of Accounting and Organisational Behaviour courses in order to get a holistic education.

2. **B.B.A. LL.B.** (**Hons.**) The B.B.A. LL.B. (Hons.) programme combines the study of law with management and finance. Course on Management, Finance, Human Resource Management, Strategic Management, Accounting and Economics, are taught as part of the Business Administration discipline. Students are also introduced to select subject of social sciences and humanities like Sociology, Political Science, Economics and English Language and Literature.

Innovative Programmes: University has offered and started the following innovative programmes during the year:

A. **Bachelor of Vocational Education** (**B.Voc**):- This year, with the approval of UGC, NLU Odisha is offering three-year Bachelor of Vocation (B. Voc) in **Access to Justice Programme**. The programme will focus on two primary areas – Criminal Justice and Child Rights. This is an attempt to develop proactive role in educating the public about

law and formulate legal empowerment using legal services and paralegal education. The course will also make an attempt to contribute to bring the law closer to people and to reach out to communities. It will make efforts to strengthen legal aid and institutionalising paralegal education. NLUO is committed in promoting access to justice for all and to cater unmet legal needs is important mandate of the university to implement its social justice mission. The UGC had launched this scheme on 27 February, 2014 for skills development based higher education as part of college/university education, leading to Bachelor of Vocation (B.Voc.) degree with multiple entry and exit points. Aimed at holistic development of the students, the B. Voc programme is a blend of knowledge-based and skill-based education. Any student with 10 +2 pass in any stream can join the programme.

Objectives of the B. Voc Programme

- To provide judicious mix of skills relating to legal and related disciplines.
- To ensures adequate legal knowledge and skills
- To make students work-ready at each exit point of the program.
- To integrate skill components to enhance employability of the graduates.

The experience gained through the Paralegal Program of Community College supported by UGC community college which has been successfully completed this academic year in June 2018 was an eye opener on the extent, reach and interest of community-based paralegals emerging from the villages.

B. Distance Education: (i) University is in the process of finalising three distance education programmes, namely, Child Rights, Taxation and RTI. For the first time a comprehensive programme on child rights is being offered with the support of the UNICEF. The three under-graduate courses are being offered as MOOC IGNOU courses. (ii) In addition, a UGC-PG MOOC course on **Law & Justice in the globalizing world** is also being prepared and is ready to be launched.

(iii) Online course on Social Entrepreneurship would be offered soon. A MoU has been

signed with the Wadhwani Foundation for this purpose.

C. "LexTech Centre" – Centre for Law, Entrepreneurship and Innovation established in the year 2015 helps young entrepreneurs turn ideas into viable businesses. In partnership with mentors, corporations, development agencies, NLUO community and investors, LexTech cultivates a rare breed of entrepreneurs by incubating, accelerating, mentoring and funding innovative start-ups.

NLUO organised second edition of tech-stars start-ups weekend powered by google for entrepreneurs from 3rd to 5th August 2018. The event saw the participation of more than 30 budding entrepreneurs from various fields and backgrounds. The participants are given 54 hours to make their start up ideas into a fully formed business with a domain and required technical know-how. The judges for the event were Ramanuj Mukherjee, the founder and CEO of legal education startup, iPleaders; Avelo Roy, MD and CEO of Kolkata Ventures, the largest startup incubator in Eastern India supporting more than 350 startups; and Digbijoy Chakraborty, Director of Public Sector and Government Consulting in MENASA region at Frost & Sullivan, business consulting firm.

D. Foreign Language: The university started the foreign languages courses in German and French in the last academic year, the same are completed during the present academic session.

E. Performing Arts: Certificate courses on Odisi dance and Indian music (Vocal) were started in 2017. These courses are completed during the present academic session.

F. Innovative Courses as Part of Regular Curriculum: Regular course of Law & Entrepreneurship is being offered to the 5th year students. University also offered 01 single credit courses during the year.

G. Innovative Courses on General Affairs and ICT: University is signing MoU with the Indian Institute of Technology Bhubaneswar (IITB) to help and support the university in the following areas: (i) Introduction of course on General Studies and Current Affairs (ii) Development of basic course on ICT for law students including Data Page and Programming relevant to lawyers and judges in India to inculcate use of technology in decision making, cyber law and cyber forensics.

H. International Executive Course on Juvenile Justice: NLUO has finalised the program for offering International Executive Course on Juvenile Justice in collaboration with University of Geneva and IDE, Centre for Rights of the Child, SION, Switzerland. This program would be launched before the end of 2018.

I. Public Health Law: University is working on the development of course on 'Public Health Law' in collaboration with Public Health Foundation of India.

J. Other New Courses: The University is in the process of developing other important courses like **Agriculture, Irrigation and Water Law**, Course on Short Film and Documentary Production' etc. These courses would be soon introduced to the students.

H. Adapting the Curriculum to Syllabus of Competitive Exams: To increase the employability of the students and to help students appearing in various competitive exams the Academic Coordination Committee has asked the faculty to adapt the relevant curriculum to the requirements of the competitive exams like Civil Services and Judiciary Exams.

1.2 (i) Flexibility of the Curriculum: CBCS/Core/Elective option / Open options

Core Subjects:

The syllabus for all subjects of UG, PG and research methodology for Ph.D is periodically revised before the commencement of the new semester two months in advance. This semester particularly the syllabus revision was carried to not only incorporate the recent trends but to align it with UPSC

syllabus and syllabus of State Judicial Services in the core subjects like Legal History, Constitutional Law, Criminal Law, Law of Evidence, Contract Law and Mercantile Law.

During the revision of course syllabi, emphasis is now being laid to restructure the course modules, and incorporate blended learning, flipped classroom techniques and integrates it with SWAYAM courses.

As a matter of practice before the end of a semester, the course syllabus for the next semester is revised for all the subjects and all faculty members and subject experts (external and internal) give their opinion and inputs on the relevance of the course and specific modules so as to address contemporary issues and hone the practical skills of students.

Elective and Optional Courses:

The University has introduced several innovative courses as part of electives and optional courses during this academic session. Some of the innovative courses are 'Law on Dispute Resolution in International Trade', 'Regional Trade Agreements', 'Energy Law', 'Access to Medicine and Patents' and 'Child Rights'.


Other innovative courses like Media Law, **Law & Entrepreneurship**, RTI, Litigation Management, Maritime Law, Criminology, Mergers and Acquisitions, Corporate Insolvency, Copyright Law in the Entertainment Industry, Privileged Class Deviance, International Commercial Arbitration, Securities Law, Animal Welfare Law, Democracy, Election Law and Inclusive Governance, Medical Law and Ethics, Telecommunications and Broadcasting Law, Infrastructure Law, Laws on Mines and Minerals, International Criminal Law, Biotechnology Law etc. Introduced earlier as seminar papers and are continuing as part of the regular academic curriculum.

Value Added Courses:

Various value added courses were also offered during the present academic session including Language Courses – German and French, Odissi Dance Course, Happiness Programme, Photography Course and Single Credit Course on Tribal Rights was offered by Prof. Premananda Panda in 2018.

The feedback obtained from students is structured but from other stakeholders feedback is obtained in informal ways for the betterment of the institution.

University is in the process of having a Registered Alumni Association. After the process is completed more structured response from Alumni would be possible. At present University gets the feedback through informal process from Alumni who are in contact with the University and visit University for various purposes. Some Alumni are also employed in the University as a faculty or in Research positions.

Feedback system is an important device employed the university to improve itself and reframe the curriculum, change the teaching techniques and adapt to global market needs. The feedback

obtained from students is structured but from other stakeholders feedback is obtained in informal ways for the betterment of the institution.

Student Feedback: National Law University, Odisha conducts a student feedback session at the end of every semester to assess the performance of teachers on various parameters: knowledge of subject, teaching methodology, communication skills and class management & sincerity and fairness. Pertinent to the course curriculum feedback, certain questions are asked on teaching methodology like whether raising questions by students were encouraged in class, whether reading materials provided by the course teacher were relevant and useful for the course, if the teacher provided reasons and grounds for the propositions discussed in the class, if the teacher gives examples and illustrations to aid the learning process, and whether the teacher explained the kind of answers expected from the students in the examination. On the basis of this feedback, suggestions to teachers are given to constantly evolve and become and epitome of success.

Teachers Feedback: From teachers feedback is taken every Wednesday and a consultation follows so as to improve the curricular aspects and update the modules with recent case laws and contemporary global issues and problems. The feedback from teachers helps to identify the themes for faculty development programs and other workshops which are conducted from time to time.

Employers Feedback: Feedback is taken from chambers of senior lawyers, law firms, judges, HR dept of PSU's to assess the overall suitability of NLUO graduates in the profession. Based on the responses that were received it has been observed that most of them have appreciated the LLB structure for being comprehensive, especially the wide range of seminar subjects that are offered. On the basis of the feedback some of seminar subjects recently offered are Real Estate Laws in India, Energy Law, Maritime Law Election Laws, Corporate Mergers and Acquisition.

Alumni Feedback: The Alumni are asked about the relevance of the courses taught and the university and the need to constantly revise the curriculum. Their views on examination pattern are also elicited. Most of the alumni agreed that the fundamental courses taught at NLUO laid a strong foundation. However, some of them have the opinion that the courses should be taught with a more practical approach. Courses like Corporate Law, Tax Law, and Banking Laws should be

taught with a more focus on the practical aspects, according to some students. Alumni practising in the High Courts and Supreme Courts feel that the foundation courses in law like Constitutional Law, Contract Law and Criminal Law have been useful. Some special courses like Affirmative Action and Distributive Justice & Comparative Constitutional Law have also been lauded by alumni from the first batch of NLUO. About the best practices associated with some of the courses at NLUO, many alumni have pointed out the incorporation of projects, presentations, assignments (individual and group) in each subject helped in honing of research, analysis, writing and public-speaking skills simultaneously. They also wrote that the reading materials in the courses are of superior quality and so students have access to well-written academic sources at the undergraduate level which is a rare feature not available at all Indian universities. Applicationbased questions in the examinations at NLUO were appreciated by most alumni. They suggested more time for internships course in last year and accordingly university grants case to case basis extensions.

Parents Feedback: The discipline and overall contribution by a child in his social environment are two major concerns of the parents. They are constantly in touch with the university authorities through hostel administration. They are apprised of their wards performance regularly through their registered emails. On the basis of the suggestions of parents university now offers regular counselling (online and offline) to address the mental health issues of the students.

The syllabus for all subjects of UG, PG is periodically revised before the commencement of the new semester two months in advance.

During the revision of the course syllabi, emphasis is laid to update and restructure the course modules, and incorporates blended learning, flipped classroom techniques and integrates it with SWAYAM courses. During this semester some courses on Research Methodology, Corporate Law, Criminal justice, Criminal Law, Information and Communication Technology and HRM have been integrated with SWAYAM to the possible extent.

1.5 Any new Department/Centre introduced during the year. If yes, give details.

The Centre for Access to Justice become more active as NLUO has joined as the participating institute under the Unnat Bharat Abhiyan program which is the flagship program of Ministry of Human Resource Development for upliftment of rural India. In pursuance of this NLUO has adopted five villages in 2018 to provide access to justice to the rural population.

2.6 Innovative processes adopted by the institution in Teaching and Learning:

National Law University, Odisha has adopted various innovative methods in teaching, learning and evaluation process.

Integrating and MOOC and SWAYAM Courses: NLUO is introducing MOOC and Swayam courses in regular courses as a method of flipped classroom technique of teaching and learning. Presentations by students and group discussion in the class room are a regular feature of the learning process. In addition to the above, the University is the continuing innovations made in the previous academic year as given below.

Tutorial Classes - With a view to improve academics and to ensure that performance of students get better scrutiny by the teachers, NLUO is offering tutorial classes in all subjects in addition to regular classes. The object of these classes is to ensure that all the students have interaction with the faculties and thereby clarifying the doubts.

Teaching Seminar Course - National Law University Odisha has always been committed to enriching the academic exposure of the students in various aspects of the legal profession so that they are best equipped to deal with the demands of their professional life. In furtherance of the same objective and in order to further expand the academic experience of the students, the University is offering Teaching Seminar Course to the 4th year and 5th year students in the Under Graduate Degree Programme and to the LLM students. Under this programme, select students are attached to particular teachers in subjects of their choice or to paralegal courses. In this they are assessed on the basis of teaching in some classes and preparation of class notes and reading materials. The University is hopeful that apart from helping the students who are interested to pursue higher studies or are interested to join academics, the Teaching Seminar Course will also provide a unique learning opportunity for peer to peer learning whereby senior students may be able to help junior students in different subjects outside the classroom.

PIL & Legal Aid Clinical Course - University has also started compulsory Legal Aid and PIL course for 3rd year students. Students are divided into groups and each group works on one issue of social relevance. In this way students have been divided into six groups, namely, Community Advocacy, Prison and Legal Service, Child Rights, Labour Rights ,Land Rights and Right to

Education. Students have to do field work, collect information from the people and prepare draft report of their experience. The object of this course is to bring the field experience into the class room and thus they would be in a position to understand the gap between the law in theory and in action.

Ph.D. Scholarship- NLUO is offering monthly scholarship of Rs. 15000/- (Fifteen Thousand) to the full time PhD scholars to enable them to meet the expenditure for their research.

3. Research, Consultancy and Extension

3.1 Initiatives of the IQAC in Sensitizing/Promoting Research Climate in the institution

After discussion in IQAC, Academic Council of the University has approved to provide seed money to Research Centres. IQAC in the latest meeting suggested for setting up an ethics committee for Research. Faculty are encouraged to submit minor and major Research Proposals for funding. To encourage research and publications University is entering into MoU with professional publishers. Faculty are encouraged to apply for fellowships abroad. 



3.26 Major Activities during the year in the sphere of extension activities and Institutional Social Responsibility

Unnat Bharat Abhiyan: NLUO has joined as a participating institution in the Unnat Bharat Abhiyan and has adopted 5 villages in and around Cuttack to extend its contribution for legal assistance and awareness and promote development of rural India. The university is in process of developing '**Rural Practicum Course**' to integrate Unnat Bharat Abhiyan activities into the curriculum.

IDIA Odisha Chapter- NLUO has successfully completed number of sensitization activities in the academic year. The last sensitization in Dompara district was very successful and at least 20 students qualified for INAT. Details of some of the sensitization programs are given below:

- (i) In-house sensitization involving house-keeping staff –All the members f housekeeping staff of NLUO were oriente on the possibilities of law as a career, IDIA initiative and how it could help them.
- (ii) DAV Public School Cuttack- Students of class XI and XII attended the session while 60 students appeared in INAT.
- (iii) Kendriya Vidyalaya 2, Cuttack- The team addressed about 200+ students.

Legal Aid Clinic: NLUO's Legal Aid Clinic had adopted three districts for the purpose. Under the Unnat Bharat Abhiya NLUO has now adopted 5 villages. Faculty members and students periodically organise legal aid clinics for the purpose. It is student body and played a very significant role in raising general awareness of rights and law in remote communities across the state of Odisha by organising Legal literacy Programs in innovative ways, Legal aid clinics are covering prisoners, labourers, farmers, women, Children and persons from SC/ST communities.

Litigation Management in Higher Education in Odisha: This project is run by National Law University Odisha in collaboration with Department of Higher Education, Government of Odisha. Though huge numbers of cases are filed in courts every month, there are little databases of the pending cases in many departments. This project work commenced on February 20, 2017 and funded by World Bank will help the government of Odisha in monitoring all the cases ongoing against them in addition to better utilization of resources.

Litigation Free Village: LL.M. (2017-18) students taking the course on Access to Justice and Legal Empowerment with aim of freeing one village from litigation, conducted a needs assessment survey in the village Pathapur. They identified that there was no criminal case involving the villagers but there were four civil issues which was forwarded to the Legal Aid Society, NLUO as part of community service.

In the long-term the project will seek to cascade the clock.uk.net web portal, through an India specific web mechanism to assist monitor, analyse and promote access to justice across India. The project will be led collaboratively by an interdisciplinary team of law academics within CLOCK and the All India Access to Justice Strategy, led by Dr Krishnadas, CLOCK (Keele University), and Associate Prof Sukumaran, nominated lead of the National Law Schools in India; hosted by Prof Srikrishna Dev Rao, Vice Chancellor, NLU Odisha, in collaboration with Prof Venkata Rao, VC NLSIU, Bengaluru, and Prof B.B. Pande, University of Delhi, and with the members of the judiciary, legal profession, charities and court sector in UK and India.

Study Abroad Program On Law And Justice In Collaboration with Centurion University and University of Victoria, Australia: Students from University of Victoria, Australia visited India in January 2018 to become familiar with the functioning of Indian Legal System in ensuring access to justice. This visit was funded by Government of Australia. NLUO partnered with Centurion University in this programme.

(b) Second stream deals with preparation of IAS and other Administrative Examinations; and


(c) Third stream deals with the CS examinations.




2. University is part of IDIA program which help in the preparation of CLAT examinations. It helps visually challenged and other students in need of support.





6. Governance, Leadership and Management

6.1 State the Vision and Mission of the institution

The mission of National Law University Odisha, Cuttack is advancement of learning, teaching and Research and diffusion of knowledge in the field of law as also to cater the need of the society by developing professional skills of persons intending to take up advocacy, judicial service, legal service or service for the legislative drafting as their profession and matters connected therewith and incidental thereto, who will uphold the values of rule of law and democratic principles. NLUO aims to discover, preserve, and disseminate knowledge; produce creative work; and promote a culture of broad inquiry throughout and beyond the legal fraternity. NLUO also aims, through public service, to enhance the lives and livelihoods of our students and the people of Odisha. Themes in the values include excellence, diversity and inclusion, openness, and collaboration, social justice and access to justice.

6.2 Does the Institution have a management Information System - Partial.

National law University Odisha, Cuttack intends to venture in the field of e-governance and ERP Implementation in the education sector. Library maintenance is already automated. It is looking forward to the assistance of the MHRD for developing a comprehensive information management system.

6.3 Quality improvement strategies adopted by the institution for each of the following:

6.3.1 Curriculum Development

The university actively indulges in quality improvement and assurance practices for curriculum development. We take the suggestion from the experts to meet both the professional needs of the education and academic excellence. The curriculum of every semester is discussed and deliberated upon at the beginning of every semester by the Academic coordination committee in the presence of all the faculty members and comments on each course and suggestions for improving them to make the course more diverse and learner friendly is invited and taken.

The university regularly updates the knowledge of its faculty by means of faculty development programmes and meetings with the experts. It also invites various experts' comments on the present curriculum and thereby makes the desired changes in same. For the development of curriculum and reading material, the university has recently conducted various Faculty Development Programmes.

Our efforts in the quality improvement strategies has been appreciated all around and given recognition as well and our University being made the member of the committee constituted by NALSA to develop the model curriculum for the teaching of clinical courses in law schools and universities, bears a testimony to the same. We have 5 dedicated faculty members working under the leadership of the Hon'ble Vice Chancellor for creating an ideal curricular framework for clinical legal education and vocational programmes for paralegals.

6.3.2 Teaching and Learning

The university believes in regular updating of knowledge and opening up diverse avenues of learning for its students and faculty. In view of this, the university has invited experts in the field of law in the past year to offer various single credit courses on contemporary and emerging areas like International Human Rights, Corporate Social Responsibility, Tribal Rights, Economic and Social rights, Maritime Law, IP and Access to medicine, Land Governance: Law and Policies and Criminal Law Policies, to help the students to gain first-hand knowledge and skills in relevant fields. The University regularly invites eminent academicians and experts from industry for delivering guest lectures and also for offering courses for shorter durations.

University before the end of a semester regularly conducts course presentation for the coming semester. In addition to it regular curriculum development workshops are organised by the university. In the previous academic year two curriculum development and teaching workshops were organised. Following innovations have been brought in this year:

1. University initiated the integration of MOOC and SWAYAM Courses in the regular courses from the current semester. This is being done to develop flipped classrooms and

blended learning mechanisms. Courses which have been identified include Research Methodology, HRM, Criminal Law and Criminal Justice etc.

2. New elective courses have been introduced as part of regular curriculum. These are courses on Mines and Minerals, Energy Law, Child Rights, Corporate Taxation, Animal Welfare, WTO Dispute Resolution Mechanism, Regional Trade Agreements etc.

3. New elective courses have been introduced as Certificate Courses: Course on Foreign Language and Performing Arts have been introduced to students diverse learning experiences. These are optional courses and separate certificates are given to students who successfully complete these courses.

NLUO is actively engaged in providing clinical legal education to its students where they can get a first-hand experience of the legal field. We teach as many as 5 clinical papers in our course duration of 5 years.

To provide affordable legal education to masses, NLUO has established the Centre for Distance Education. The university is going to commence the Child Rights, Taxation, Entrepreneurship Development and Right to Information courses under the aegis of the Centre for Distance Education.

NLUO is also a host institute of the Global Initiative of Academic Networks (GIAN) through which Scholars and experts of International and National repute are invited for offering credit courses in the University.

6.3.3 Examination and Evaluation

Examination and evaluation pattern remain largely the same based on continuous evaluation system and transparency. One innovation that was made in the last academic year is the "Teaching seminar course" Teaching seminar course as an optional seminar course is offered to undergraduate post graduate students wherein they are assigned to particular teachers depending the subject they have chosen for the course. The evaluation for the course is done on following parameters:

• Performance in classes conducted: 30 Marks

- Preparation of Research Material and Lecture Notes: 30 Marks
- Preparation of Reading Material in a Related Advanced Area (by a Panel): 40 Marks

6.3.4 Research and Development

The University has established various research centres to promote the research. During the course of year the university has reshuffled the existing centres. In addition to the existing 16 Research Centres, three research centres, Centre for Lex Tech, Centre for Film Studies and Centre for Maritime Law have been added to the University.

NLU, Odisha is providing the technical support for implementation of State Plan in the Child and Adolescent Labour (Prohibition and Regulation) Amendment Act, 2016.
- Litigation Management in Higher education in the State of Odisha: This project is run by National Law University Odisha in collaboration with Department of Higher Education, Government of Odisha. Though huge numbers of cases are filed in courts every month, records of the pending cases in many departments. This project work commenced on February 20, 2017 and funded by World Bank will help the Government of Odisha in monitoring all the cases ongoing against them in addition to better utilisation of resources.
- Exploring the Changing Dynamics of Children's Laws in the Post Liberalisation Era This is an ICSSR project which has following components: (i) Juvenile Justice (ii) Child Labour (iii) Right to Education (iv) Prevention of Sexual Abuse of Children. The Research is complete and the University is in the process of finalising and submitting the final report.

In the long-term the project will seek to cascade the clock.uk.net web portal, through an India specific web mechanism to assist monitor, analyse and promote access to justice across India. The project will be led collaboratively by an interdisciplinary team of law academics within CLOCK and the All India Access to Justice Strategy, led by Dr Krishnadas, CLOCK (Keele University), and Associate Prof Sukumaran, nominated lead of the National Law Schools in India; hosted by Prof Srikrishna Dev Rao, Vice Chancellor, NLU Odisha, in collaboration with Prof Venkata Rao, VC NLSIU, Bengaluru, and Prof B.B. Pande, University of Delhi, and with the members of the judiciary, legal profession, charities and court sector in UK and India.

- Child Rights Centre: The Centre for Child Rights supported by the UNICEF regularly research on different issues related to rights of the children. It regularly conducts sensitization and training programs which are mentioned in 3.26. This is an ongoing project and funds are released periodically on the basis of programs to be conducted.
- Centre for Women and Law has published in collaboration with Satyam International an edited volume entitled 'Socio Legal Status of Unwed Mothers: Issues Challenges and Way Ahead'. The book is edited by NLUO faculty namely, Prof. Rita Ray, Prof. Aruna Srilakshmi and Ms. Snigdha Singh.
- New Centres in Pipeline: University is in the process of setting up new centres like The Centre for Research on Economic Offences and Financial Fraud (CREOFF) in collaboration with PLR chambers Delhi.

6.3.5 Library, ICT and physical infrastructure / instrumentation

The university offers Advanced Vocational Diploma Programme for paralegals under 'Barefoot Lawyers College' from 2016. In addition to this, the University is planning to offer a Bachelors in Vocational Education for paralegals under the University's 'Barefoot Lawyers College'. This will be a 3 year course with both classroom and field based/skill based component in the curriculum, with a maximum intake of 50 students. 6.11 Activities and support from the Alumni Association

NLUO encourages active interaction with alumni as it believes that a strong alumnae base would cater towards the development of college. They are invited to train and orient the current students in extra-curricular activities like mooting, drafting of memos, debating etc. The alumni are called to judge the annual intra University moot court competition as well as the national and international level moot court competitions organised by the University every year. Their assistance has been laudable particularly with respect to dealing of legal aid Cases.

Though, the university does not have an institutionalised alumni body as of yet, but NLUO Alumni Association will be soon set-up as a registered society. Much of the work in this regard has already been done.

6.13 Development programmes for support staff

Following initiatives were taken by the university in the last year in this regard:

- 1. The University encouraged its support staff members to appear for Matriculation examination and provided them with all support to help them clear the examination. Some faculty members took special classes for them to teach a particular paper and clear their doubts so as to help in the preparation of the staff members for the exam.
- 2. Staff members, who have intermediate degrees to their name, were encouraged to enrol for the UGC sponsored Advanced Vocational Diploma Programme for paralegals under 'Barefoot Lawyers College'. About 9 staff members enrolled in the course and benefitting from it as it would be an additional vocational degree that would be added to their name. To encourage the staff members to join the course, the University provides them an additional stipend of Rs. 1000/- per month during the course. Currently the University is planning to

introduce Bachelor in Vocational Education (B. Voc.). The support will be extended to the enrolled members of the University to join that.

- Apart from these dedicated efforts, University also organises various capacity development programmes for the staff members, like One Day programme on Behavioural Competency (organised by Dr. Harish) on 22nd July, 2017, and Barefoot Counselling Programme (organised by YourDost, an emotional wellness platform) on 21st December, 2017.
- 6.14 Initiatives taken by the institution to make the campus eco-friendly
- 1. The University has a dedicated and well functioning Sewage Treatment Plant to treat the waste generated by our University campus before it is discharged out of the campus. With regards to the other garbage generated by the University, the University has an arrangement with the Cuttack Municipality which ensures timely clearing of the garbage from the campus.
- 2. The University has already procured solar panels and it's in the process of being installed on the building's terraces, throughout the length and breadth of the university campus.
- 3. The college campus has been declared as Non-smoking zone. The faculty, students, staff of the college, as well as the visitors are not allowed to smoke within the college campus.
- 4. Most of the office work follows paperless organization through E-filing system.
- Recently a National Conference on Animal and Environmental Welfare was organised in collaboration with Humane Society International: India on 25th & 26th of September, 2018.
- 6. University has a student society named 'Friends Beyond Species' Society for advancement of Animal & Environmental Welfare.

7. Innovations and Best Practices

7.1 Innovations introduced during this academic year which have created a positive impact on the functioning of the institution. Give details.

The university has introduced several innovative techniques in teaching and learning process to make the learning more interesting and meaningful. The following best practices are introduced by the university:

Promotion of Research and Innovations in the field of Law:

The University is attempting to develop the research culture and Peer Group learning. We encourage the synergy between teaching and research. The evidence based research where in new facts; ideas are gathered, empirically tested in multi-disciplinary mode and results in creation of new knowledge in field of law and social sciences. The University promotes research among the faculty members for which we conduct *Wednesday Seminar Series*. In faculty seminars teachers share their latest research work. The university also invites experts on regular intervals for interaction with teachers.

We have various research centres engaged in research activities in diverse areas of law. The **Centre** for **Child Rights** has conducted several workshops and training programmes. The Centre will be offering the **International Executive Course on Juvenile Justice in November 2018 in** collaboration with University of Geneva and IDE, Centre for Rights of the Child, SION, Switzerland.

The **Centre for Access to Justice** has recently completed a project on Access to Justice for Marginalised People and Socially Relevant Legal Education in collaboration with Department of Justice and UNDP.

We are the first university in India to offer the *Vocational Diploma Programme for Paralegals* with the support of the UGC under the Barefoot Lawyers College. Recently, the UGC has approved

our proposal to upgrade it as *Bachelor of Vocational Education Programme in Access to Justice f*rom this year.

University initiated the integration of MOOC and SWAYAM Courses in the regular courses from the current semester. This is being done to develop flipped classrooms and blended learning mechanisms. Courses which have been identified include Research Methodology, HRM, Criminal Law and Criminal Justice etc.

Various value added courses were also offered during the present academic session including Language German, Language French, Odissi Dance Course, Happiness Programme, Photography Course and Single Credit Course on Tribal Rights by Prof. Premananda Panda

7.2 Provide the Action Taken Report (ATR) based on the plan of action decided upon at the beginning of the year

 Infrastructure: In Infrastructure facility, construction of second girls hostel has progressed. Two blocks out of four blocks with 90 rooms have been constructed and have been occupied. Other two blocks would be constructed in due course and the library would be completed soon depending on the availability of financial assistance.

2. Research and Publication:

(a) Faculty members of the University have received fellowship for summer school and Research abroad. Prof. (Dr.) Sri Krishna Deva Rao has received Fulbright Nehru International Education Administrators Seminar Fellowship for 2018-19. Dr. Rangin Pallav Tripathi has got Fulbright Fellowship for Post-Doc Research in Harvard Law School. Mr. Pallab Das has got Scholarship for Summer School on International Commercial Arbitration and European Crisis.

(b) Some of the Research Projects of the Research Centres have been completed. These are DoJ Research project on 'Comparative Analysis of the Performance Appraisal Mechanism and Schemes of Promotion in Relation to the Judges of Subordinate Judiciary in Different States'; DoJ project on 'Functioning of Lok Adalts in the Eastern Region of India'.

(c) One project ICSSR project on Exploring the Changing Dynamics of the Children's Laws in India in the Post-Liberalsiation Era' is near completion. Centre for Child Rights is continuously getting projects from UNICEF.

(d) Centre for Women and Law has published the book on 'Socio-Legal Status of Unwed Mothers: Issues, Challenges and Way Ahead' in collaboration with Satyam International. It is edited by faculty members Prof. Rita Ray, Dr. Aruna Sri Lakshmi and Ms. Snigdha Singh.

(e) Centre for International Trade Law has completed working on edited volume on Trade Facilitation and WTO and is in the process of publication by Cambridge Scholars Press. It is edited by Prof. Jane and Winn and Prof. Sheela Rai.

3. Teaching and Learning:

(a) New Courses have been introduced as detailed 1.1.

(b) University has updated its Ph.D. rules in line with UGC Ph.D. Rules of 2016.

(c) University has carried further the collaboration with institutions with which it had signed MoU. University is offering International Executive Course on Juvenile Justice in collaboration with Geneva University and IDE Centre for Child Rights Studies SION, Switzerland.

(d) Outside experts have been invited for guest lectures, talks and information dissemination. Some of them are Prof. Permanand Panda, Hon'ble Justice Michael Kirby who was also awarded Doctorate Honoris Causa in 2018 by NLUO. Visitors are regularly called under the programs organised by the Informal Discussion Group. Some of them are Mr. Mani Shankar Aiyer (diplomat turned politician), Dr. K. Kasturirangan (former ISRO Chief and Chancellor JNU), Mr. Gautam Bhatia, Dr. Arghya Sengupta (Founder Vidhi Centre for Legal Policy). University organises public lectures on two occasions One is Foundation Day Lecture. This year His Excellency Sri Ram Nath Kovind, Hon'ble President of India delivered the third Foundation Day Lecture on 17th March 2018. Second Saila Bala Pujari Lecture was delivered this year by Ms. Ruma Pal (Former Judge Supreme Court of India). Ms. Maneka Gandhi, Hon'ble Minister for Women and Child Development, Government of India, was keynote speaker on the occasion of the inaugural session of two day National Conference on Animal and Environmental Welfare.

4. **Best Innovative Practices:** NLUO is carrying one with the competition like 'Hunar' 'IUMCC' which bring out multifaceted personality of students. This year NLUO also conducted First Annual international Essay Writing Competition on Securities and Competition Law in collaboration with Surana and Surana (Law Firm). University has also introduced new courses like course on Foreign Language, and Course on Performing Arts. This encourages students to develop all their potentials to the fullest extent. University has also continued to publish the student magazine in which students contribute stories, essays, paintings, and poems

7.4 Contribution to environmental awareness / protection

The university is committed towards the betterment of the surrounding environment. National Law University Odisha is situated at a beautiful place in the outskirts of the millennium city Cuttack. The campus is located in midst of two rivers, namely Mahanadi and Kathajodi which is also near to Naraj Barrage. We have lush green campus with plants and trees of variant qualities. The State Forest Department, National Coconut Board and District Forest Department have helped the University for plantation of the trees. The university is also taking services of an independent agency to maintain and upkeep the trees, plants and lawns.

The University has taken number of measures, while designing and constructing its campus to take the maximum usage of the natural resources and selected electrical equipments, which will consume less energy as compared to the traditional equipments. In addition to this the university is making sincere efforts for protection and conservation of the surrounding environment. The following efforts are being made by the university:

i) Energy Conservation:

NLUO has taken few measures to save more energy as the campus is under development and it has number of plans which will be implemented in due course of time.

a) We have executed an automatic mechanism for light system of Street Light, Lights in the Landscaping area etc.

b) We have preferred the execution of CFL / LED lights instead of the traditional lighting equipments.

c) All the buildings are well lighted with the day-light because of the Open-to-Sky (OTS) areas. The Academic Block, Administrative Block and the Hostels are well planned with such an Energy saving architect.

d) The air-conditioning system in the Academic & Administrative Blocks are centralised but each outlet units have individual remotes to control.

ii) Use of Renewable Energy:

The Government of Odisha has installed solar panels in free areas of the university. The solar panel outlets are installed at top of the Administrative Building, Academic Building, Boys Hostel – I, Boys Hostel – II, Girls Hostel and Parking Lots. These panels shall be on lease for the duration of twenty five years. The solar panels will have the capacity of 250 KW and the electricity produces will be directly given to the grid. However the government will reduce the amount of electricity bill equivalent to the electricity produced through the solar panels installed in the university. The solar panels are already installed in the campus but the same is required to be started by the government.

iii) Water Harvesting:

For water Harvesting, NLUO has made some endeavours and more in the plan as the construction of the campus is going on.

Sewage Treatment Plant

a) The university has constructed two Sewage Treatment Plants for recycling the Sewerage Water. These Sewerage Treatment Plants (STP) are attached to the Hostels and other buildings of the University. The water recycled from these plants is used in irrigation / watering the plants.

b) There are provisions for recharge wells to store rain/flood water and to use the same in plantation areas etc.

iv) Efforts of Carbon Neutrality:

The basic and the major step to neutralise the Carbon / CO2 is plantation, the University has made its campus green by planting different genre of trees with the help of State / District Forest Departments, Horticulture Department. In addition to this the surrounding of the University also has many well-groomed trees.

v) Plantation:

As mentioned above, we are emphasising upon making the campus as much green as possible and almost 60% of the area is kept for plantations / making lawns.

vii) Hazardous Waste Management:

We have Sewerage Treatment plants to dispose the sewage wastes and recycle the water to be used for irrigational purposes. Along with the same, the Cuttack Municipal Corporation also co-operates in taking away other waste including Solid Wastes.

Percentage of power requirement of the University met by the renewable energy sources

At present the solar panels are installed in the campus but the operation of same will start in near future.

University Grants Commission in March 2018 granted us the graded autonomy recognising us as an excellent University imparting quality legal educational in India. We are the third National Law School among four National Law Schools that were granted the autonomy status. We have also been ranked recently as the **third best National law school** in India in this year's India Today's Ranking of best law schools in India.

The vision of the University is to develop as a Centre of Excellence in Legal Education and emerge as a place of professional learning and nurture the idea of serviceability to the people. In order to translate this vision, the University orients students to cater to the needs of the society by developing the professional skills of those intending to take up the professions of advocacy, judicial services and legal services.

The University is working with full dedication to achieve the vision with the help of faculty, administration and students. The university is also providing technical assistance to the State Government regarding several legal issues. In addition to the regular research work, the university has established student committees for conducting several activities in the university. These committees bring together the students of different batches. The student committees are working under the guidance of the faculty advisers. The students of University have excelled in the field of moot court and achieved several national and international titles to their names.

Study Abroad Programme on Law and Justice in India

This January 2018, the university has hosted Study Abroad Programme on Law and Justice in India for 15 Australian students from Melbourne and Victoria University.

The university is working for the excellence of the socially relevant legal education. The university is able to achieve this target with the help of learned faculty members, hard working administration and students. The university has following future plan:

Excellence in Research:

The University always promotes research for which there are more than sixteen research centres in different divisions of law. The mail aim of these centres is to promote dedicatedly in the research activities. The centres have completed several projects and some other projects are near completion.

8. Plans of Institution for next year

The University is dedicated to achieve the academic excellence. We have introduced several programmes for the benefits of the students. The university has planned to offer the courses for increasing employability of the students. These are:

- (i) Law & Entrepreneurship: The University will be offering Basic and advanced courses in *Entrepreneurship in association with Wadhwani Foundation*, Bangalore. In addition to these courses, we also offer one Credit Courses in different emerging areas. The proposed credit courses for this academic year are Bonded Labour and Women Trafficking, Public Health and Policy, Corporate Governance and Environmental Law and Policy.
- (ii) New Inter-disciplinary Courses: We are working on development of new courses such as, Public Health Law in collaboration with Public Health Foundation of India, Agriculture, Irrigation and Water Law, Computer Programming for Lawyers. With help of IIT, Bhubaneswar and Bombay the university will produce Short Film and Documentary.
- (iii) Lead in Massive Open Online Courses (MOOCs): We have trained our Teachers to develop Distance Education and MOOCs courses with the help of Staff Training Research and Development (STRIDE), IGNOU, New Delhi, National Institute of Educational Planning and Administration, (NIEUPA), New Delhi.

Our University is developing six (6) Online MOOCs courses, one course with UGC and Five Courses with IGNOU, New Delhi. They are: *Law and Justice in globalizing world* with UGC Swayam and *Child Rights, Preventing Child sexual Abuse, Access to Justice and Legal Empowerment*, Right to Information and GST.

Blended Courses: We will also offer some blended courses of MOOCs and class room teaching in this semester.

Improving the Infrastructural Facilities: The University has constructed the ground floor and first floor of the girls' hostel – II. Further, the second floor and third floor is to be constructed in near future. The university has also constructed the outer structure of library, the finalisation and fabrication of same is required to be completed in near future. University is also seeking assistance from MHRD for developing the Information Management System. The next phase of the construction will include the construction of faculty and staff quarters, cricket ground and other required infrastructure.

Completion of the Pending Projects: University has to complete World Bank project on Litigation Management in Higher Education which it would complete by the next year. The project on Exploring the Changing Dynamics of Children's laws in post Liberalisation Era funded by the ICSSR is due for submission and would be submitted soon.

Structured Feed Back from All Stake Holders: The University has structured feed back system in case of students on the academic issue. But it is working on getting structured feedback from other stakeholders as well like the employers and parents.

Functional Alumni Association: University is in the process of completing the formation of a formal Alumni Association. It would be registered as a Registered Society and University plans to make it functional by the next year.

Strengthening Distance Education Programs: University has a distance education centre. Already the university is preparing **MOOC** courses as detailed above. In addition to them University is also working towards developing **Legal Literacy Materials** for undergraduate students who are not from the legal discipline in collaboration with Orissa State Open University. Course outline has already been prepared.
