

**ADMISSION NOTIFICATION FOR VACANT SEATS IN B.A.LL.B. / B.B.A.LL.B.(HONS.) / LL.M.

The candidates who have appeared in CLAT-2018 under any category and their names are reflected in the CLAT-2018 Merit List, desirous to take admission in the B.A.LL.B. (HONS.) /B.B.A.LL.B.(HONS.) / LL.M. programme at NLU, Odisha, should make an application expressing their interest in seeking admission in the Prescribed Format (as at Page-2) and submit through e-mail (scanned copy of application) at admissions2018@nluo.ac.in latest by 02:00 p.m. on 7th July, 2018. The interested candidates need to deposit an application fee of Rs. 1,000/- (Rupees One Thousand Only) through SBI collect (as at Page 3 & onwards). The application form fee will be non-refundable and non-adjustable in any case

A merit list against the vacant seats, strictly according to CLAT-2018 Rank will be published on 7th July, 2018 at www.nluo.ac.in.

The candidates whose names are published in the provisional selected list will be required to report at the University campus in person on 12th July, 2018 at 10 am for Counselling & Admissions. At the time of Admission, they are required to submit the documents (Please check the Link "[List of Documents to be produced on the day of Admission](#)" for the details of documents required) and the Demand Draft of Rs.1, 81,000/- for UG & Rs.1,21,000/- for PG Programme drawn in favour "Registrar, National Law University Odisha", payable at Cuttack. If a Candidate whose name appeared in the merit list, but he / she does not appear for Counselling & Admission on 12th July, 2018 with all required documents along with the Demand draft, then his/her candidature will be forfeited and the seat will be offered to another candidate as per the merit. The Candidates should come prepared to stay in the hostel and to attend the classes from 12th July, 2018.
