The Constitutional Law Society, NLUO and Ronald Dworkin Study Circle organized “Professor Ronald Dworkin Memorial Lecture” on the topic “Democracy, Dissent and Indian Supreme Court” on 26 June 2020 at 5 PM. Lecture was delivered by Mr. Salman Khurshid, Former Union Minister, Law and Justice and External Affairs, Government of India. In this address Mr. Khurshid reflected on the writings of Ronald Dworkin and its relevance in Indian jurisprudence. Hon’ble Mr. Justice A. K. Sikri, Former Judge, Supreme Court of India delivered presidential address highlighting Supreme Court decisions which tried to protect the culture of dissent in Country.

Dr. Lokendra Malik, Advocate Supreme Court welcomed all the guests and Prof. Shruti Bedi, Professor of Law, UILS Punjab University moderated the programme. Professor Yogesh Pratap Singh, Professor of Law and Registrar, NLUO while expressing gratitude towards both eminent speakers, panel members and participants also stressed on the decline of dissent not in general but also in judicial decision-making.
