

**Notification for admission to B.A. LL.B. (Hons.) / B.B.A. LL.B. (Hons.) / LL.M.
Programme for the Academic Year 2020-2021 under Foreign
Nationals/NRI/NRI Sponsored / PIO / OCI Category**

Out of the total 120 seats of B.A.LL.B. (Hons.) and 60 seats for B.B.A.LL.B. (Hons.) Programme, 15 Seats (10 in B.A.LL.B. & 5 in B.B.A.LL.B.) are allotted to NRI/NRI sponsored / PIO / OCI candidates and 6 seats (4 in B.A.LL.B. & 2 in B.B.A.LL.B.) are allotted to Foreign Nationals. Similarly in LL.M. Programme 4 seats are allotted to NRI/NRI sponsored / PIO / OCI candidates and 2 seats are allotted to Foreign Nationals. The unfilled seats in Foreign Nationals Category will get converted to NRI/NRI Sponsored / PIO / OCI Category and to General Category subsequently.

Candidates who wish to apply to B.A.LL.B. (Hons.) / B.B.A.LL.B.(Hons.) / LL.M. Programmes for the Academic Session 2020-2021 under Foreign Nationals / NRI / NRI Sponsored / PIO / OCI Categories need to send the duly filled in application form, other relevant documents and a proof of deposit of application fees etc. directly to the University through admissions2020@nluo.ac.in before 05.10.2020 (5th October, 2020). the application form can be downloaded from our Website i.e. www.nluo.ac.in. The application fee of ₹ 20,000/- (Rupees Twenty Thousand only) must be sent through NEFT/RTGS to the bank details as below:

Candidates of the above mentioned categories shall fulfil other requirements regarding age and qualifications as per CLAT-2020 and NLUO eligibility Regulations.

The candidates under Foreign National Category shall be admitted directly on the basis of their 10+2 / Intermediate marks. The merit list of Foreign Nationals will be determined on the basis of their 10+2 marks. If there is a tie, then the marks of 10th standard will be taken into consideration. If still there is no change in rank then, the higher in age shall get preference or in case of need the final admission will be done based on a lottery.

However, applications under NRI / NRI Sponsored / PIO / OCI Category shall be considered for admission in case the candidate had appeared for CLAT 2020 under NRI/NRI Sponsored / PIO / OCI Category. They shall send the filled in application form along with the copy of the admit card of CLAT 2020, other relevant documents and prescribed fees. They shall be admitted as per their Rank in CLAT 2020, depending upon the vacancies.

This amount of ₹ 20,000/- is not refundable but adjustable in the fee payable by the candidate. ***The said amount will be forfeited in case the candidate is shortlisted/ called for admission but not reported for admission as on given schedule.*** However, Rs. 18,000/- will be refunded after a deduction of Rs.2,000/-towards administrative charges, in case she/he is not getting shortlisted/called for admission at NLUO, Cuttack. Once the candidate is admitted under the Foreign Nationals / NRI / NRI Sponsored / PIO / OCI Category the admission will not be converted into any other category subsequently.
