

**Notification for admission to B.A. LL.B. (Hons.) / B.B.A. LL.B. (Hons.) / LL.M.
Programme for the Academic Year 2021-2022 under Foreign Nationals Category**

National Law University Odisha invites application for admissions to 6 seats in UG Programme (4 in B.A.LL.B. & 2 in B.B.A.LL.B.) and 10 seats in One year LL.M. programme for the Academic Session 2021-22. Over and above these seats, in case seats reserved for OCI, PIO, NRI and NRI Sponsored Category remain vacant, they may be filled by Foreign Nationals Students.

The Foreign Nationals interested to apply for any of the above programme under the Foreign Nationals Category need to email the scanned copy of the filled in application form in the prescribed format along with a clear Statement of Purpose, other relevant educational and experiential certificates and proof of payment of prescribed fees etc. directly to the University fn-admissions@nluo.ac.in. The short listing of candidates under Foreign National Category will be done as follows:

The Admission Committee will shortlist the applications on the above parameter and will call the candidates for online interactions/personal interview to judge the ability of the students to pursue the applied programme and judge the candidates proficiency in English. Candidates with a TOEFL/ILETS Score will be preferred.

Candidates who wish to apply under Foreign Nationals Category need submit the duly filled in application form which can be downloaded from our Website i.e. www.nluo.ac.in with all supporting documents along with a proof of online transfer 270 \$ in favour of Registrar, National Law University Odisha, in the following bank account. Please Note that the online transfer/wire transfer charges should be included in the application fee, this has to be borne by the candidate.

The filled in application and other documents must reach the fn-admissions@nluo.ac.in on or before **Saturday, 5.00 P.M. (1700 Hours of IST) 24th July 2021**. Selected candidates should complete the admission formalities by paying required fees on the scheduled dates to be announced in the University Website: www.nluo.ac.in.

The application fee of 270 \$ is not refundable but adjustable in the fee payable by the candidate. *The said amount will be forfeited in case the candidate is shortlisted/ called for interview/admission but not reported/ accepted the offer of admission as per the specified timeline which will be informed by the Admission Office.* However, the University will refund 200 \$ after a deduction of 70 \$ towards administrative charges and online transfer fee/wire fee, in case she/he is not getting shortlisted for admission at NLUO, Cuttack. Once the candidate is admitted under the Foreign Nationals category the admission will not be converted into any other category subsequently.
