







About CLS


About the Course



Through this certificate course, we aim to foster an environment where the students are able to appreciate the inextricable connection between Constitutional Law and Economics. We further wish to expose the students to the relevance of the same in contemporary times. The goal is to help students to be in a better position so as to:

- Understand the practical application of classroom teaching in diverse spheres of the legal field.
- Analyse economic policies and schemes from a constitutional lens.
- Learn the economic analysis behind constitutional questions and the tools and techniques employed therein.
- Gain skills that can be useful in public policy research or think tank set-ups.
- Expose them to the notional thinking of professionals involved in this process.

The teaching time for the Course would be spread over 20 hours. The classes will be held on the weekends (most of them being Saturdays and Sundays) in the forenoon, afternoon and evening. Teaching time on any day would not extend beyond 4 hours so as to enable students to absorb the contents taught. Certificates will be provided to the participants after the conclusion of the course.







Prof. Mukul Asher

Prof. Mukul G Asher obtained Ph. D. in Economics from Washington State University in 1972. He was a faculty member with the Department of Economics, and later with the Lee Kuan Yew school of Public Policy at the National University of Singapore for over four decades, stepping down in June 2018.

He has been a Visiting Faculty at the Asian Public Policy Program at Hitotsubashi University in Tokyo since the early 2000s. He is associated with several Indian think-tanks. He is a Distinguished fellow at Dr. Syama Prasad Mookerjee Research Foundation (SPMRF) in New Delhi; and Senior Adjunct Fellow at Research and Information System for Developing Countries (RIS) in New Delhi.

His research focuses on public financial management, pension reform, and on expanding India's geo-economic and geo-strategic space. He has published extensively in national and international journals; and has authored/edited more than 16 books.


Dr. K P Krishnan

Dr. K P Krishnan joined the Indian Administrative Service (IAS) in 1983 and has served in various field and secretariat positions in India in the Government of Karnataka and Government of India. Dr. Krishnan also served as Adviser to the Executive Director (Dr. Bimal Jalan), World Bank during 1994-97. He served as Secretary, Economic Advisory Council to the Prime Minister from July 01, 2010 till 13th August, 2012.

Dr. Krishnan is the IEPF Chair Professor in Regulatory Economics. The Chair has been established with the support of the Investor Education and Protection Fund Authority of the Government of India. Before his retirement from public service in December 2019, Dr Krishnan was the Union Secretary in the Ministry of Skill Development and Entrepreneurship.

Trained in economics, finance, and law; Dr Krishnan has chaired or served as a member of several Government of India committees, including the Krishnan Committee on Cross Border Insolvency Rules/Regulations Committee, the Krishnan Committee on Comprehensive Regulation of Credit Rating Agencies and the T K Viswanathan Committee on Reform of Bankruptcy Laws in India.




Dr. Suryaprakash Misra

Dr. Misra returned from the USA with an M.S. (Applied Economics & Statistics) from Clemson University. While at Clemson University, as a Graduate Teaching Assistant, he taught Principles of Economics and Experimental Statistics to undergraduate students for two and a half years. After his stint at Clemson, Dr. Misra joined the School of Law, KIIT University, Bhubaneswar in January 2010 as an Assistant Professor (Economics), and was there till August 2012. After that, he was with NALSAR University of Law, Hyderabad, as an Assistant Professor (Economics) till August 2016. Since then, he has been with the National Law University Delhi as an Assistant Professor of Economics since 2016.

He has academic publications on various sub-disciplines of Economics such as Microeconomic Theory, Bargaining Theory, Industrial Organization, Development Economics, International Trade, Poverty and Inequality, Public Finance/Economics and Law and Economics.

Mr. Lalit Panda

Mr. Lalit Panda is a graduate of the Gujarat National Law University, Gandhinagar, and has been working in the Public Law team at the Vidhi Centre for Legal Policy, New Delhi since 2017. Prior to joining Vidhi, he worked briefly as a Consultant with the 21st Law Commission of India. At Vidhi, he has worked in the broad areas of law and technology, regulation, and constitutional law, providing legal and policy research on subjects such as data protection, higher education, election law, and fiscal federalism

As a Samvidhaan Fellow, Mr Panda aims to conduct interdisciplinary research into the equal protection guarantee in the Indian Constitution, examining a range of recent and long-standing controversies regarding the right to equality through the lens of Law & Economics. Applying transaction cost analysis as well as insights from other disciplines regarding the significance of uncertainty, he hopes to develop new methods of constitutional design and interpretation related to reasonable classification in-laws, disparate impact, and the design of affirmative action programs, amongst other such subjects.





Panel Discussion



After attending the classes, it becomes imperative to provide the students with a platform where they can discuss on the contemporary developments on the issues. Keeping this in mind, a panel discussion will be organized on 6 February, 2022, with the theme "Emerging trends in constitutional economics in India and its place in the global scenario"

It will be a 2 hour event, beginning with a discussion between our four Course instructors, who are luminaries in their own fields, moderated by the Faculty Advisor of CLS and Assistant Professor of Law at NLUO, Ms. Rishika Khare. It will be followed by a *Question & Answer* session for the attendees.
