## Odisha State Child Labour Survey

Seeking total elimination of child labour in the state, the Odisha government has formulated a “State Action Plan for Elimination of Child Labour”. As a part of the said initiative, the Labour Commissioner has also requested NLUO to finalize a team of researchers and professionals who would work with the Labour Department not just for the survey but also in the long run for various intensive activities for elimination of child labour in the State of Odisha.

## Analysis of the Functioning of Lok Adalats in Eastern India

This project is aimed at studying the prevalent state of affairs as regards the functioning of Lok Adalats in the Eastern Region of India and then scrutinizing the performance of Lok Adalats in terms of statistical parameters to have a more comprehensive understanding of the structural capacities and deficiencies.

## Start-Up Odisha

The main objective of the MOU is to provide all types of legal assistance to Startup Odisha, conduct seminars, workshops, Startup Weekends, training Programmes in collaboration with Startup Odisha, Collaborative research and teaching, research findings, and publications. The terms and conditions of the MOU will be executed through Lextech – Centre for Law, Entrepreneurship and Innovation, NLUO.

## NYAAYA

The Legal Aid Society, NLUO in pursuance of our objective to serve society, especially in these uncertain times has collaborated with NYAAYA (Vidhi Centre) on their newly launched initiative. Nyaaya has launched a COVID Whatsapp helpline number to assist people by answering any legal questions that they may have during the existing crises. The purpose of this helpline is to empower people with the knowledge of their rights and enable them to take action.

## Police-Academia Interaction Forum (PAIF)

The forum would focus on facilitating a mutually beneficial interaction among police officials and academics and students. It would provide the students practical exposure to the workings of the police and real-life exposure to investigation and law enforcement through academic interactions and internships in various departments of the state police.

# FLAGSHIP EVENTS

## International Maritime Arbitration Moot Court Competition

The Moot Society is the official body of NLUO which oversees moot activities in the university. The society's flagship event – International Maritime Arbitration Moot is organized in the month of March annually. We, at NLUO, have chosen Maritime Law as the subject matter to complement the maritime operations in Odisha and consequently promote intellectual discourse in the field of Maritime Law. The NLUO-IMAM has created a niche for itself as it is the first moot competition in India and third moot competition in the world to have maritime law as its principal subject area. In the previous editions of the moot, we have successfully hosted the event with the support of Bose & Mitra Co. as our title sponsors and our knowledge partners EBC and SCC Online. NLUO-IMAM has earned a name of its own, currently being the biggest maritime arbitration moot in India



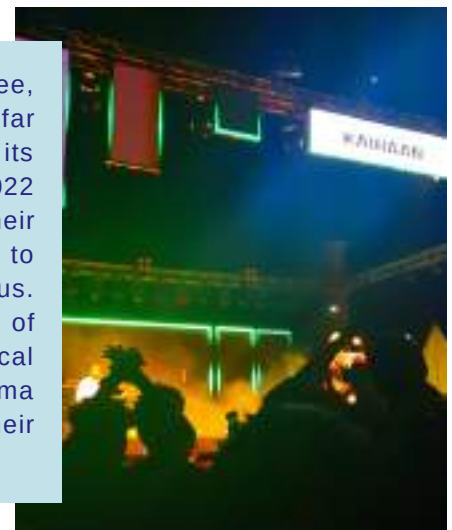
## VIRAJ

Apart from hosting an assortment of various eateries, Kairaan 2022 witnessed food stalls organized by NLUO students portraying both their entrepreneurship and cooking skills alike. Kairaan organizes a plethora of events to keep the participants engaged across the 3 days they spend in the NLUO campus. From organizing stage events such as – dance competitions through variety of segments including the western dance-off, and eastern performances; musical events which allow the participants to portray their musical passion; drama competitions which enables the participants to stage their talent and express their emotions; and the fashion show which brings out the fashionista in everyone.
